Remark

1. Stone Colour is not matching the sample provided.
2. 20% only of the goods packed into ctn, and 50% only of the production is ready after factory QC.
3. There are two common defects which were found in most of the samples taken: a) 70 out of 80 pcs were had uneven inside waistbands and uneven stitching. b) 72 out of 80 pcs with belt not lying straight along with the waistband.
4. The marks on the ctn box is different from buyer approved master ctn.
5. The polybag dimension is 17.5*13 instead of 17.5*12.5.

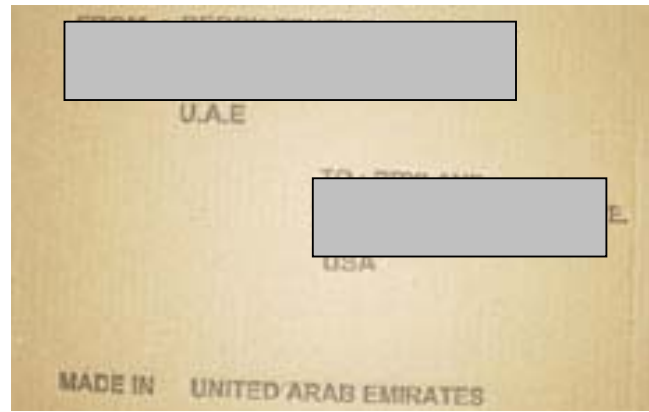
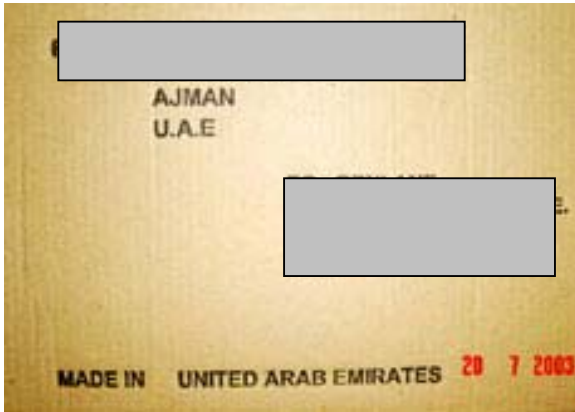

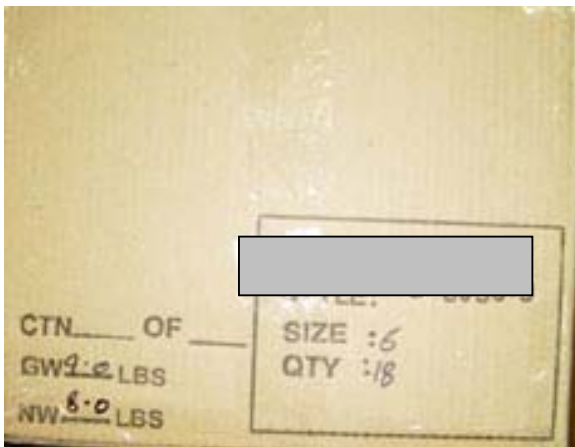
